This letter supersedes my letter of 25 August 2006 that transmitted proposed Subcontract Amendment 15 that would incorporate into the Subcontract Revision 12 to the Product Specification. Because of errors and omissions that Specification has been further revised. The Amendment was not fully executed by the parties.

As permitted by General Provisions Cause D3. Changes – Fixed Price, Princeton Plasma Physics Laboratory (PPPL) hereby incorporates into Subcontract S005242-F by means of proposed revised Subcontract Amendment No. 15 attached to this letter:

- ❖ NCSX Product Specification, Modular Coil Winding Forms, NCSX-CSPEC-141-03-14 (Revision 14), dated 6 September 2006.

This Amendment is effective upon receipt.

Subparagraphs (b) and (c) of the General Provisions Clause D3 grants the following rights to the Subcontractor:


- “(b) If any such change causes an increase or decrease in the cost of, or the time required for performance of any part of the work under this Subcontract, whether or not changed by the order, Princeton shall make an equitable adjustment in the Subcontract price, the delivery schedule, or both, and shall modify the Subcontract.

- (c) The Subcontractor shall assert its right to an adjustment under this clause within 30 days from the date of receipt of the written order..."
