# FIXED-PRICE SUPPLY SUBCONTRACT S005243-F

FIXED-PRICE SUPPLY SUBCONTRACT S005243-F, as amended, by and between THE TRUSTEES OF PRINCETON UNIVERSITY and MAJOR TOOL & MACHINE, INC. (MTM) for the performance of the requirements of <u>National Compact Stellarator Experiment (NCSX) Statement of Work, Vacuum Vessel Sub Assembly (VVSA) Fabrication</u> is hereby further amended. The primary purpose of Amendment No. 4 to Subcontract S005243-F is to incorporate into the Subcontract:

- ❖ A revised delivery schedule (ARTICLE I),
- ❖ An extension of the Subcontract performance period (ARTICLE II).
- ❖ An increase in the Subcontract fixed-price and Princeton Plasma Physics Laboratory's (PPPL's) funding obligation, resulting from the parties settlement of a MTM claim, and a revision of the PPPL incremental funding schedule (ARTICLE IV),
- ❖ A revision of the Performance Based Payment schedule (ARTICLE V), and
- Requests for Deviations submitted by MTM and approved by PPPL (ARTICLE XII – MODIFICATIONS OF SPECIFICATION).

B. The text of ARTICLE II - <u>PERIOD OF PERFORMANCE</u> is hereby revised to read:

"This Subcontract shall be effective from the date signed by both Parties through 15 February 2006, unless sooner terminated, or extended, in accordance with the terms and conditions herein. The Subcontract delivery schedule is in ARTICLE I – SCOPE OF WORK. "

- C. The text of paragraphs 1. and 9. of ARTICLE IV <u>CONSIDERATION</u> / <u>LIMITATION OF OBLIGATION</u> is hereby revised to read:
  - "1. For the performance of the requirements of this Subcontract Princeton agrees to pay the Subcontractor the Fixed-Price of four million, nine hundred sixty-seven thousand, two hundred four dollars (\$4,967,204).

This includes an increase of four hundred thirty-one thousand, six hundred forty-four dollars (\$431,644) agreed to by the parties as settlement of a MTM 4 February 2005 claim for "vessel profile changes." The parties agree this claim settlement is with the caveat that in the event MTM were to make additional price increase requests, except in response to PPPL directed work scope changes, the settlement is void and PPPL's final performance milestone payment of \$486,000 would be reduced accordingly. Discussions of PPPL's contractual obligations to pay the above amount would then become part of the discussion of PPPL's obligation with respect to all of MTM's cost claims.

PPPL will obligate funds to this Subcontract incrementally. With the issuance of this Subcontract Amendment No. 4 the sum of four million, two hundred thirty-one thousand, two hundred four dollars (\$4,231,204) is presently available for payment and allotted to this Subcontract. A schedule for allotment of funds to this Subcontract is contained in paragraph 9. of this Article."

"9. The parties contemplate that Princeton will allot funds to this Subcontract in accordance with the following schedule:
